

Privacy policy.

This Privacy Policy defines how INDIGOCLUSTER L.L.C-FZ collects, uses, stores and discloses information received from users on the website <https://wetalents.pro> (The "Site"). The main provisions of our Privacy Policy.

We do not disclose your personal information to third parties.

We do not share your contact information without your personal consent.

You independently determine the amount and extent of the personal information disclosed.

Information collected.

Personal information that you knowingly provided personally during the registration procedure on our Website.

Technical information that is collected automatically by the software during a Site visit, and which becomes available to the Site administration from standard server logs.

The personal information provided by you during registration is not subject to verification for authenticity.

All technical information, including your IP address and the files that you upload, is analyzed by us on an aggregated basis to further develop

suggestions for improving and developing the Site.

The relationship between the IP address and your personal information is not subject to disclosure to third parties, except as required by law.

Information about Site visits is recorded by installed statistical counters.

The purpose of using the information received.

Personification of your work with the Site and anonymous preparation of statistics based on parameters such as activity on the site, time of visit, the address of the site that brought you to our Site.

Evaluating the effectiveness of our advertising, promotions and campaigns to promote products and services.

Simplify the use of the Site, as well as adapt its work and our products to your individual needs and interests.

The purpose of using the information received about you.

The purpose of using your personal information.

Prompt provision of information about upcoming events.

Answers to your questions or comments.

We do not store information collected for certain purposes for longer than the period necessary to achieve these goals, except in cases of a legal nature.

In the process of deleting information from servers in order to protect it from intentional or accidental hacking, we cannot immediately eliminate residual copies from servers or backup systems.

Providing information to third parties.

In no case, except as required by law, do we disclose or provide your personal information to third parties.

Using Cookies.

The use of small text Cookies, which are stored on your computer using a web browser and work as a user identifier, can be used for subsequent automatic authorization on the Site and the collection of statistical data. It is important to know and remember that we never store any personal data or passwords in these files.

If for any reason you do not trust the use of Cookies technologies, then you have the right to prohibit the saving of files on the computer that provides access to our Site.

Links to other sites.

We are not responsible for the privacy policies of other websites that may be linked to on our Site.

Data protection.
